

# **American Psychiatric Association PsychiatryOnline Institutional Agreement (License) Perpetual Access eBook Collection**

The following paragraphs are hereby added to the American Psychiatric Association (APA) Single Site License Agreement, at Paragraph 6, "Archive Policy." This Addendum shall take effect immediately upon signature and receipt of the one-time payment for the Perpetual Access eBook Collection.

By purchasing a Perpetual Access eBook Collection, the Licensee has perpetual and irrevocable access rights for the contents included in the eBook Collection in the year of purchase (**listed in Appendix 1**):

- i.** The Licensee and Authorized Users shall be able to access the content that is included in the Perpetual Access eBook Collection from Authorized Sites only.
  
- ii.** The contents of the Perpetual Access eBook Collection constitute the complete content license under this Addendum and are not to be confused with the "Licensed Materials" under the Single Site License Agreement.
  
- iii.** If a new title edition is added to the eBook Collection, the previous title edition will be phased out. The Licensee will be notified via email sixty (60) days prior to a title's removal from the eBook Collection on Psychiatryonline.org. The Licensee may retain ownership of this title by downloading the title during this sixty (60) day period.
  
- iv.** If the Licensee would like to gain perpetual access to titles and new editions released after the year of their purchase, they will have the option of paying a Supplemental Fee. This Supplemental Fee will be available for content added in the five (5) years following their initial year of purchase.

The Terms and Conditions of the Single Site License Agreement shall apply to Licensee's access to the content in the Perpetual Access eBook Collection. To the extent the terms of this Addendum are inconsistent with those of the Single Site License Agreement, this Addendum governs Licensee's access to the Perpetual Access eBook Collection and the use of its contents. By signing below, you certify that you have read and agree to abide by all such Terms and Conditions and you certify that you are authorized to sign this form on behalf of your institution.
